EXECUTIVE ORDER NO. 01-A - 2023

ADDENDUM TO EXECUTIVE ORDER NO. 01-2023, REORGANIZATION OF THE PROVINCIAL BIDS AND AWARDS COMMITTEE (PBAC) AND THE PBAC SECRETARIAT AND FOR OTHER PURPOSES

WHEREAS, Article V, Section 11 of the Government Procurement Reform Act (RA No. 9184) provides for the creation and establishment of Provincial Bids and Awards Committee (PBAC), which shall be responsible for all procurement activities of the Provincial Government in accordance with the provisions thereof;

WHEREAS, Executive Order (EO) No. 01-2023, issued on the 3rd day of January 2023, provides for the reorganization of the Provincial Bids and Awards Committee (PBAC) and the PBAC Secretariat, amending EO No. 01-2022;

WHEREAS, there is a need to update the members of the PBAC and PBAC Secretariat in accordance with the directive of the undersigned and for the efficient function of the office;

NOW, THEREFORE I, EDWIN "BOBOY" B. HAMOR, Governor of the Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the amendment of Executive Order No. 01-2022 and 01-2023 and reorganizing the PBAC and PBAC Secretariat which shall now be read as follows:

"Section 2. Composition: The Provincial Bids and Awards Committee (PBAC) shall be composed of the following:

The former PBAC Secretariat under Executive Order No. 01-2023 is hereby relieved of its duties and responsibilities. They are mandated to report back to their official station. They are further directed to turn over immediately all the documents and instruments related to the bids and awards to the newly created PBAC Secretariat."

This Executive Order shall take effect immediately upon its issuance as stated hereunder.
