EXECUTIVE ORDER NO. 20 - 2023

CREATING THE SORSOGON PROVINCIAL DEVELOPMENT TEAM FOR THE CALINTAAN-CALAYUAN ISLAND DEVELOPMENT PROGRAM AND FOR OTHER PURPOSES

WHEREAS, on April 25, 2023, the Provincial Government received communication dated April 14, 2023 signed by the Regional Director of the Department of Tourism-Bicol, Herbie Aguas, stating among others the solicitation of recommendations and proposals for TIEZA-owned/operated program;

WHEREAS, the Provincial Government intends to participate and submit development proposals for the tourism industry in the Province;

WHEREAS, in its initial meeting with concerned departments, the Governor and concerned department heads identified the Island of Calintaan as the area that will conform to the criteria defined by the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) as a possible area to develop to become a competitive tourist destination; and

WHEREAS, to ensure that the proposed project for the island of Calintaan is approved by TIEZA, there is a need to create and establish a team that will ensure the viability of the program;

NOW, THEREFORE, I, EDWIN “BOBOY” B. HAMOR, Governor of the Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the following:

Section 1. Creation and Establishment of the Sorsogon Provincial Calintaan-Calayuan Island Development Team (SPCCIDT). – The Sorsogon Provincial Calintaan-Calayuan Island Development Team (SPCCIDT) is hereby created.

Section 2. Functions and Responsibilities. The functions and responsibilities of the SPCCIDT Team shall be:

- a. To ensure that all the documentary requirements for evaluation by the TIEZA Board are complied with;
- b. To schedule site visits in the Calintaan Island in order to determine all development in the tourism industry needed by the program;
- c. To make sure that the constituents involved the concerned barangays be informed of the program and that they are amenable to the projects to be implemented therein;
- d. To lobby the proposed program to TIEZA Board;
- e. To make representation to the Sangguniang Panlalawigan for the creation of the Calintaan-Calayuan Island Development Administration;
- f. To create a Technical Working Group that will ensure the technical aspects of the program are properly carried; and
- g. Other relative functions to be done from time to time or as may be given to them by the Governor;

Section 3. Composition. – The SPCCIDT Team shall be composed of the following personnel:

Section 4. Incorporation Clause. – All laws, legal order, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines are hereby incorporated herein and made an integral part hereof. In case of conflict,

such laws, legal order, rules and regulations shall have precedence over provisions of this Executive Order.

Section 5. Repealing Clause. – Any Administrative Order or Executive Order previously issued that is inconsistent with the provisions of this Executive Order shall be considered repealed, amended, or modified accordingly.

Section 6. Effectivity. – This Executive Order shall take effect immediately upon its issuance as stated hereunder.
