**EXECUTIVE ORDER NO. 07 - 2023**

**PROVIDING FOR AN ANNUAL MEDICAL AND DENTAL CHECK-UP, HOSPITALIZATION, AND OTHER MEDICAL BENEFITS TO ALL OFFICIALS AND EMPLOYEES OF THE PROVINCIAL GOVERNMENT OF SORSOGON AND FOR OTHER PURPOSES**

**WHEREAS**, Civil Service Commission (CSC) Memorandum Circular No. 33 s. 1997 provides that pursuant to CSC Resolution No. 97-4684, dated December 18, 1997, all government offices shall provide health program for government employees including hospitalization services and annual mental and medical-physical examinations;

**WHEREAS**, Provincial Ordinance No. 1-2020 of the Sangguniang Panlalawigan (SP), also known as "Annual Health Care Benefits of Sorsogon Provincial Government Employees," is an ordinance providing for annual medical and dental check-ups, hospitalization, and other medical benefits to all Provincial Officials and Employees of the Provincial Government of Sorsogon, and providing funds therefor;

**WHEREAS**, the Provincial Government of Sorsogon places utmost importance on the health of its employees for the efficient and effective function of every office and its continuous delivery of public service; and

**WHEREAS**, the Provincial Government of Sorsogon must conduct an annual medical and dental check-up in compliance with the CSC Memorandum and the SP Provincial Ordinance;

**NOW, THEREFORE I, EDWIN "BOBOY" B. HAMOR**, Governor of the Province of Sorsogon, by virtue of the powers vested in me by law, do hereby order the holding of an annual medical and dental check-up and the provision of hospitalization benefits and other medical benefits for all officials and employees of the Provincial Government of Sorsogon.

The Provincial Health Officer, Dr. Renato B. Bolo, Jr., is hereby directed to prepare and set a date for these annual provincial government medical and dental check-ups.

The Provincial Government shall allocate funds for the annual check-ups and the hospitalization and other medical benefits in accordance with

the appropriation of funds set under Section 11 of SP Provincial Ordinance No. 1-2020. Other sources of funds may also be mobilized for this purpose.

**Separability Clause.** – If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected shall remain valid and subsisting.

**Incorporation Clause.** – All laws, legal order, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal order, rules and regulations shall have precedence over provisions of this Executive Order.

**Repealing Clause.** – Any Administrative Order or Executive Order previously issued that is inconsistent with the provisions of this Executive Order shall be considered repealed, amended, or modified accordingly.

**Effectivity.** – This Executive Order shall take effect immediately upon its issuance as stated hereunder.
